ENTRIES: OPEN with a postmark date of April 10, 2018 and CLOSE with post mark of May 1, 2018. Any entry postmarked after May 1, 2018 will be charged at the post-entry rate. In the event of duplicate postmark dates, a drawing will determine which entry will be accepted. Checks not honored by the bank do not constitute a valid entry. Refunds will not be made after closing date unless the entry is filled from a waiting list. Run orders determined by random draw in advance of the trial. Bitches in season will run in the order drawn. Substitutions will be allowed. Day of trial entries, if available, will be taken at 7 am each day for both trials that day. Checks payable to TCASWA and mail to Trial Secretary at address listed above. \$25 service charge for returned checks. Divisions Offered: ADVANCED, OPEN, STARTED, NOVICE, JUNIOR. *Cattle entries may be limited based on number of head of stock able to be obtained.

RIBBONS: 1st through 4th place and High Score for each trial.

AWARDS: *HIT awards for highest score in each stock each trial.

*Three High Combined Awards will be awarded: 1) High Combined Australian Shepherd, 2) High Combined Other Breed, 3) Most Promising Started (any breed). To qualify for High Combined awards, you must enter at least 3 complete trials (all 3 stock) of the 4 offered. To qualify for Most Promising Started, you must enter at least 3 complete trials (all 3 stock, all in Started). However, if you enter all 4 trials, the lowest score in each stock will be dropped.

GENERAL INFORMATION:

- 1. Dogs must be kept on leash when not working. Please clean up after your dog.
- 2. Entry forms can be obtained from the ASCA website (http://www.asca.org/formsandrulebooks).
- 3. Exhibitors, through submission of entry, acknowledge that they are knowledgeable of ASCA rules and regulations.
- 4. All ASCA approved breeds for stockdog and crosses thereof are eligible and welcome to enter. However, to earn titles, non-Aussies must have an ASCA Tracking Number. We will have forms available at the trial (we will forward them to the ASCA office) but encourage you to apply for a Tracking Number before hand. You must be an ASCA member (any category) at time you apply for Tracking Number. Forms available at (http://www.asca.org/formsandrulebooks).

*DIRECTIONS: From the South: Take the 91 Freeway East to the 71 (Chino Valley Freeway) North. Take 71 North to the Peyton / Riverside Drive exit. Turn right on Riverside Drive. Travel East 1/4th mile to McCroskey Road. (on the South / Right side of the street) Turn right on Mc Croskey Road. Drive to the end / entrance to Diamond Dogs K-9 Events. If you pass RESERVOIR Ave., you've gone too far.

<u>From the North</u>: Take the 10 Freeway East / 60 Freeway East to the 71 Freeway South. Take 71 South to the Peyton Drive exit. Turn left and drive under the 71 Freeway. Peyton Drive turns into Riverside Drive heading East. Travel East 1/4th mile to Mc Croskey Road. (on the South / Right side of the street) Turn right on McCroskey Road. Drive to the end / entrance to Winning Edge Dog Sports. . If you pass RESERVOIR Ave., you've gone too far.

<u>From the 60 FRWY</u>: Get off at Reservoir and head south. Turn Right on Riverside and a quick left on McCroskey.
