ENTRIES: OPEN with post mark of October 1, 2025. Ends with post mark of November 1,2025. Any entry postmarked after November 1,2025 will be charged at the post-entry rate. In the event of duplicate postmark dates, a drawing will determine which entry will be accepted. Checks not honored by the bank do not constitute a valid entry. Refunds will not be made after closing date unless the entry is filled from a waiting list. Run orders determined by random draw in advance of the trial. Bitches in season will run in the order drawn. Substitutions will be allowed. Day of trial entries, if available, will be taken at 7 am each day for both trials that day. Checks payable to TCASWA and mail to Trial Secretary at address listed above. \$30 service charge for returned checks. Divisions Offered: AM ONLY:Post Advanced Cattle and Sheep AM and PM ADVANCE, OPEN, STARTED, NOVICE, JUNIOR. \*Cattle entries may be limited based on number of stock available

AWARDS: \*HIT awards for highest score in each stock each trial.

\*11 SILVER BUCKLES will be awarded: 1) High Combined WTCH Aussie 2) High Combined WTCH Other Breed 3) High Combined Non-WTCH Aussie 4) High Combined Non-WTCH Other Breed 5) High Combined Open Aussie 6) High Combined Open Other 7) Most Promising Aussie 8) Most Promising Other Breed 9) High Combined Cattle 10) High Combined Sheep 11) High Combined Fowl

# **BUCKLE AWARDS - WEEKEND**

- ++ Most Promising: Must enter at least 4 trials all stock (Cattle, Sheep and Geese). If entered in all 6 trials, Top 4 scores of each class of stock will be used for calculations. Started dog can move up after 4 trials BUT only the started scores will count for the Most Promising
- **++HIGH COMBINED OPEN:** Must enter at lease 4 trials all stock (Cattle, Sheep, and Fowl). If entered in all 6 trials Top 4 scores of each class will be used for calculations. Open dog can move up after 4 trials but you must specify which buckle you are going to compete for.
- **++ HIGH COMBINED NON-WTCH**: Dogs of any breed who have not earned/qualified for the WTCH title prior to the first day of the event. Must enter at least 4 Advanced trials in all stock(Cattle, Sheep, and Fowl)
- ++ HIGH COMBINED WTCH: Dogs of any breed that has earned their:WTCH before the first day of the event
- ++ HIGH COMBINED CATTLE, SHEEP and GEESE; All breeds and divisions are eligible

A dog may compete for any high combined award as often as they like at any ASCA sanctioned trial.

- If the dog has won the Most Promising or Non WTCH from TCASWA they will be ineligible to compete for or win the same buckle. The dog is allowed to compete indefinitely at the level for which they have qualified. The dog will be eligible for all placement awards and other high combined awards offered in that class and division.
- All scores will be used in the High Combined calculations
- To be eligible for an overall combined buckle, the dog must enter all classes of stock, each trial
- Owners must be designate Non-WTCH or WTCH buckle

## **GENERAL INFORMATION:**

- 1. Dogs must be kept on leash when not working. Please clean up after your dog.
- 2. Entry forms can be obtained from the ASCA website: http://asca.org/wp-content/uploads/2016/04/stockdogentryform.pdf
- 3. Exhibitors, through submission of entry, acknowledge that they are knowledgeable of ASCA rules and regulations.
- 4. All ASCA approved breeds for stockdog and crosses thereof are eligible and welcome to enter. However, to earn titles, non-Aussies must have an ASCA Tracking Number. We will have forms available at the trial (we will forward them to the ASCA office) but encourage you to apply for a Tracking Number before hand. ## Diamond Dogs K-9 Events, 3349 Riverside Dr., Chino, California 91710

\*DIRECTIONS: From the South: Take the 91 Freeway East to the 71 (Chino Valley Freeway) North. Take 71 North to the Peyton / Riverside Drive exit. Turn right on Riverside Drive. Travel East 1/4th mile to McCroskey Road. (on the South / Right side of the street) Turn right on Mc Croskey Road. Drive to the end / entrance to Diamond Dogs K-9 Events. If you pass RESERVOIR Ave., you've gone too far.

<u>From the North</u>: Take the 10 Freeway East / 60 Freeway East to the 71 Freeway South. Take 71 South to the Peyton Drive exit. Turn left and drive under the 71 Freeway. Peyton Drive turns into Riverside Drive heading East. Travel East 1/4th mile to Mc Croskey Road. (on the South / Right side of the street) Turn right on McCroskey Road. Drive to the end / entrance to Diamond Dog K-9 Events. If you pass RESERVOIR Ave., you've gone too far.

<u>From the 60 FRWY</u>: Get off at Reservoir and head south. Turn Right on Riverside and a quick left on McCroskey.
